

**CITY OF BETTENDORF
CITY COUNCIL MEETING MINUTES**

AUGUST 3, 2020

The City Council of Bettendorf, Iowa met in Executive Session on August 3, 2020 at approximately 5:19 p.m., in the Council Chambers at Bettendorf City Hall, 1609 State Street, Bettendorf, Iowa.

EXECUTIVE SESSION – PURSUANT TO IOWA CODE SECTION 21.5(1)(i) FOR THE PURPOSE OF DISCUSSING THE ANNUAL PERFORMANCE EVALUATION OF THE CITY ATTORNEY

Mayor Gallagher explained the purpose of the Executive Session and City Attorney Chris Curran requested the Executive Session. Mayor Gallagher requested a motion to enter into an Executive Session for the purpose of discussing the annual performance evaluation of the City Attorney pursuant to Iowa Code Section 21.5(1)(i). 
