The Bremer County Board of Supervisors met in session on Monday, October 3, 2022 in the Courthouse, Waverly, Iowa, at 9:00 a.m. Hildebrandt, Neil, Kammeyer present. Kassandra Johansen, Finance Director, also present. Unless otherwise noted all actions were approved unanimously. Following the Pledge of Allegiance, the meeting was called to order by Chairman Hildebrandt. Neil moved/Kammeyer second to approve the agenda.

Board met with Scott LaRue, GIS/Maintenance for a department update. Kammeyer moved/Neil second to authorize Board Chair to sign a Client Service Agreement between Bremer County and The Shredder for secure shredding services.

Neil moved/Kammeyer second to approve the 9/26/22 minutes.

Neil moved/Kammeyer second to set mileage reimbursement rate at \$.055 per mile for 10/1/22 to 12/31/22.

Neil moved/Kammeyer second to approve payroll addition for Braeden Goding, Auditor’s Office PY/AP Clerk, full-time, \$44,000/yr effective 10/3/22.

Kammeyer moved/Neil second to approve payroll rate of pay changes for John Wehling, Jail Administrator, from \$58,252/yr to \$62,234/yr step increase, effective 10/3/22, Austin Hageman, Jailer from \$39,118/yr to \$43,120/yr orientation over, effective 10/3/22 and Cody Leech, B & Z Inspector, from \$24.84/hr to \$25.84/hr merit increase, effective 10/3/22.
