UNFINISHED BUSINESS

5. **PARKING STUDY OF HILLSBOROUGH DRIVE AND ALICANTE ROAD NEAR BEHRINGER PARK** - It is recommended the Public Safety and Traffic Commission approve the proposed parking on the north side of Alicante Road between Avenida Espana and Hillsborough Drive and along the west side of Hillsborough drive; and approve the reduction of lanes on northbound Hillsborough Drive from Alicante Road to Keypoint Place to one lane.
6. **PEDESTRIAN STUDY OF ALICANTE ROAD AND ADELFA DRIVE** - It is recommended the Public Safety and Traffic Commission deny the installation of a Rapid Rectangular Flashing Beacon; approve the installation of an Assembly “A” sign 300 feet east from the existing yellow crosswalk on Alicante Road; and approve the installation of Assembly “B” signs at the intersection of Alicante Road and Adelfa Drive for all approaches.
7. **PEDESTRIAN STUDY OF SANTA GERTRUDES AVENUE AND ASHGROVE DRIVE** - It is recommended the Public Safety and Traffic Commission deny the installation of a Rapid Rectangular Flashing Beacon; approve the installation of an assembly “D” 100 feet from the yellow crosswalk on the west leg of the intersection of Ashgrove Drive and Santa Gertrudes Avenue; and approve the relocation of Yield Signs 50’ before the northbound crosswalk.
