

HARTSVILLE/TROUSDALE COUNTY GOVERNMENT
ORDINANCE #185-2019-15

AN ORDINANCE TO ESTABLISH THE CHARTER REVISION COMMISSION

WHEREAS, the Charter of Hartsville/Trousdale County was enacted on January 1, 2001;

WHEREAS, pursuant to Hartsville/Trousdale County Charter Article 14, section 14.03 the Hartsville/Trousdale County Commission may by ordinance establish a Charter Revision Commission to hold hearings and to make recommendations to the Commission with respect to amendments of the Charter; and

WHEREAS, the Charter Revision Commission shall consist of ten (10) members, one from each Commission district; and

WHEREAS, each member should be nominated by the Mayor and confirmed by the Commission and shall serve until replaced by the Mayor.

NOW, THEREFORE, BE IT ORDAINED that the Hartsville/Trousdale County Charter Revision Commission be established, and the following shall be the structure of said Charter Revision Commission:

1. The Charter Revision Commission shall be comprised of ten (10) members, one from each Commission district.
2. The Charter Revision Commission shall elect officers annually at the January meeting.

BE IT ENACTED that this ordinance shall take effect from and after its adoption, the public welfare requiring it.
