 - TVA cooling tower is scheduled to come down in September.
 - Washington meetings - Mayor McCall met with Senator Hagerty 2 days last week in Washington, D.C. He discussed our need for a new water treatment plant. Since we are located on the river, we have the opportunity to provide water to our neighbors north of here. We will continue to work with federal and state government agencies to try to get funding for this project.
 - Curbs in town - The curb at Hartsville Taco is almost complete. The next one will be the curb across from the pet supply store where the other gazebo is. Cliff Sallee, as he always does, has worked on this with his crew and kept the cost to a minimal.
 - T.D.O.T - Hwy 10 and Old Lafayette merge has seen a lot of accidents. They are working to get some new signage and possibly a blinking light for that area to slow traffic down.
 - T.D.O.T. will also be doing a study on the E. Main/ McMurry Blvd. merge. That area is becoming more and more congested.
 - Ward School Survey is almost complete and work should begin on that project very soon.
