




Ordinance / Resolution Number: 2021-1025A

Be it ordained/resolved by the **Warren County Council/Mound Township** that for the expenses of **MOUND TOWNSHIP, Warren County** for the year ending December 31, **2022** the sums herein specified are hereby appropriated and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition, for the purposes of raising revenue to meet the necessary expenses of **MOUND TOWNSHIP, Warren County**, the property tax levies and property tax rates as herein specified are included herein. Budget Form 4-B for all funds must be completed and submitted in the manner prescribed by the Department of Local Government Finance.

This ordinance/resolution shall be in full force and effect from and after its passage and approval by the **Warren County Council/Mound Township**.

## PETITION

Members of the County Council:

Section 80 of HEA 1113-2020 adds IC 36-6-6-17 as a new statute, effective July 1, 2020. Indiana Code 36-6-6-17 imposes conflict of interest provisions for township board members. It applies to all townships except townships in Marion County. Under this new conflict of interest law, a member of the township board may not vote on the township's budget and tax levy if the member is also an immediate family member of the township trustee. "Immediate family member" refers only to the following relations: - A parent. - A sibling. A spouse. -A child. It also includes relations by adoption, half-blood, marriage, or remarriage.

Mound Township finds its unit falling under this law. Two of the three board members (John Fulton and Marsha Fulton) are the parents of Mound Township Trustee Jill Fulton Coffing. Mound Township respectfully hereby petitions the Warren County Board to perform its obligation under the law to review/approve our 2022 Budget.
