

ORDINANCE NO. 2025-____

AN ORDINANCE PURSUANT TO IC 36-2-3-4
DIVIND THE COUNTY INTO FOUR (4) COUNCIL DISTRICTS

WHEREAS, the Indiana legislature has mandated under the terms of I.C. 36-2-3-4 *et seq.* that that County Executive shall divide the County into four (4) County Council districts that are composed of contiguous territory and are reasonably compact; and

WHEREAS, the mandate further provides that district boundaries drawn by the county Executive must not cross precinct boundary lines and must divide townships only when a division is clearly necessary to accomplish redistricting under said section and districts must contain, as nearly as possible, equal population; and

WHEREAS, the Warren County Clerk has caused a study to be made in order to conform with the directives of the statute, and has presented several alternatives to the County Executive to accomplish redistricting under Indiana Code; and

WHEREAS, the Board of Commissioners of County of Warren is satisfied that the study is in compliance with state law. Under the new redistricting, Warren County has four (4) County Council districts with a population deviation of 8.7%.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Warren County as follows:

SECTION 1. The County Council Districts shall be as follows:

- District 1: Jordan Township, Kent Township, Mound Township, Prairie Township, Steuben Township, and that portion of Pine Township lying West of South Adeway Road, Rainsville Road, County Road 600 North, and County Road 100 East
- District 2: Pike Township, Washington 2 Township
- District 3: Liberty Township, Washington 1 Township
- District 4: Adams Township, Medina Township, Warren Township and that portion of Pine Township lying East of South Adeway Road, Rainsville Road, County Road 600 North, and County Road 100 East

SECTION 2: This Ordinance shall be in full force and effect from and after its passage.

SECTION 3: A copy of this Ordinance with map attached as **Exhibit A** with the district boundaries shall be filed with the County Clerk.

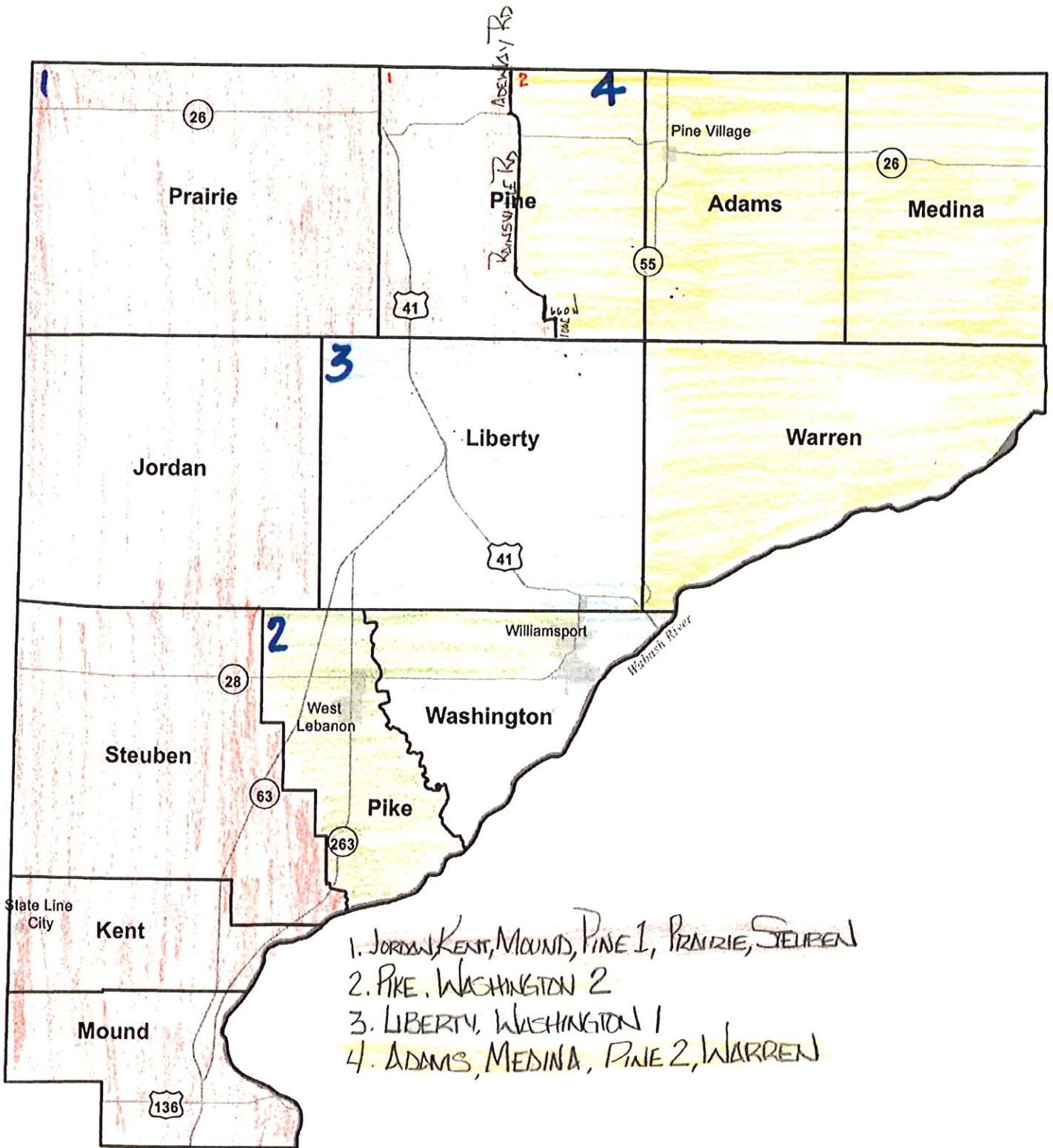
