WHEREAS, the Yuba County Health and Human Services Department (“HHSD”) is designated as the Local Lead Agency (“LLA”) for the California Tobacco Prevention Program (“CTPP”) and, as such, is responsible for coordinating information, referral, outreach and education activities that promote social norm changes and educate the public about health issues related to tobacco use and industry strategies that promote tobacco use; and

WHEREAS, the Board of Supervisors previously adopted Resolution 2022-159 authorizing the Health and Human Services Director to accept allocated funds from the California Department of Public Health for the purpose of the CTPP, for which Yuba County was allocated payments in the total amount of \$1,350,000 for the period of January 1, 2022 through June 30, 2025 under the Allocation Agreement Number CTCP-21-58; and

WHEREAS, the California Department of Public Health allocated funds to Yuba County for extended period of January 1, 2025, through June 30, 2027, a total amount of \$600,000 under the revised Allocation Agreement Number CTCP-21-58.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Yuba hereby authorizes the HHSD Director to accept \$600,000 for the period of July 1, 2025, through June 30, 2027, and to execute, upon review and approval of County Counsel, the annual Acceptance of Allocation and any subsequent documents related to this program for the stated period; to accept, allocate and transfer funds; and is further authorized to execute amendment documents for additional or lesser funding.

A copy of the fully executed agreement and any amendments thereto shall be filed in the office of the Clerk of the Board, County of Yuba.




