HNMP; AND TO ACCEPT, TRANSFER AND )  
ADMINISTER ALL THP AND HNMP FUNDS )

**WHEREAS**, the California Department of Housing and Community Development (“CDHCD”) has allocated funding of the Transitional Housing Program (“THP”) to counties for the purpose of housing stability to help young adults aged 18 to 24 years, inclusive, secure and maintain housing, with priority given to young adults formerly in the foster care or probation systems; and

**WHEREAS**, the CDHCD has also allocated funding of the Housing Navigation and Maintenance Program (“HNMP”) to counties for the support of housing navigators to help young adults aged 18 to 24 years, inclusive, secure and maintain housing, with priority given to young adults currently or formerly in the foster care system; and

**WHEREAS**, the CDHCD has allocated \$96,589 of THP Round 7 funding to Yuba County; and

**WHEREAS**, the CDHCD has also allocated \$58,787 of HNMP Round 4 funding to Yuba County; and

**WHEREAS**, to accept and receive the funding for THP Round 7 and/or HNMP Round 4, counties must submit the required application documents pertaining to these allocations; and

**WHEREAS**, if funds remain available after the application deadline, the CDHCD may advise counties of an additional allocation from these remaining funds; and

**WHEREAS**, the HHSD Director seeks to submit the required application documents to accept Yuba County's THP Round 7 allocation in the amount of \$96,589 and any subsequent funds allocated; and

**WHEREAS**, the HHSD Director seeks to submit the required application documents to accept Yuba County's HNMP Round 4 allocation in the amount of \$58,787 and any subsequent funds allocated.

**NOW, THEREFORE, BE IT RESOLVED** by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit an allocation acceptance form, on behalf of the County of Yuba, for the THP Round 7 allocation and any subsequent funds allocated.

**BE IT FURTHER RESOLVED** by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit an allocation acceptance form, on behalf of the County of Yuba, for the HNMP Round 4 allocation and any subsequent funds allocated.

**BE IT FURTHER RESOLVED** by the Yuba County Board of Supervisors that the HHSD Director is authorized to: execute, subject to review and approval of County Counsel, all documents as required for accepting the allocation for Round 7 of the THP for the term of July 1, 2025 through October 31, 2028 including subsequently extended term; execute amendments, including but not limited to amendments for additional or lesser funding; and accept, transfer and administer all THP Round 7 funds and any subsequent funds allocated for the stated period.

**BE IT FURTHER RESOLVED** by the Yuba County Board of Supervisors that the HHSD Director is authorized to: execute, subject to review and approval of County Counsel, all documents as required for accepting the allocation for Round 4 of the HNMP for the term of July 1, 2025 through October 31, 2028 including subsequently extended term; execute amendments, including but not limited to amendments for additional or lesser funding; and accept, transfer and administer all HNMP Round 4 funds and any subsequent funds allocated for the stated period.

A copy of the executed agreement or any amendment thereto shall be filed in the office of the Clerk of the Board.


