RESOLUTION NO. 2025-02

WHEREAS, the California Department of Social Services (“CDSS”) has made funds available to establish, continue, and expand housing and homelessness assistance through the Housing and Disability Advocacy Program (“HDAP”); and

WHEREAS, the HDAP is a locally administered program that provides housing supports and disability benefit application assistance and advocacy to people likely eligible for disability benefits and experiencing homelessness or at risk of homelessness; and

WHEREAS, the CDSS has Fiscal Year (“FY”) 2024-25 Noncompetitive Allocation funding available for all fifty-eight (58) counties and seventeen (17) continuing tribes. Additionally, the CDSS has FY 2021-22 Redistributed Allocation funding available for counties demonstrating the ability to utilize these funds. Counties and continuing tribes must sign and submit a Director’s Certification, complete a Budget Template, and if applicable an Expenditure Explanation to accept these funds, which do not have a match requirement and must be expended by June 30, 2025; and

WHEREAS, Noncompetitive Allocation and Redistributed Allocation funding not accepted by way of a completed Director’s Certification, including funds declined by a county or continuing tribe will be made available to grantees that indicate they can accept additional funds, as indicated in the Director’s Certification; and

WHEREAS, the CDSS has allocated \$100,000 of HDAP FY 2024-25 Noncompetitive Allocation funding plus \$297,687 of FY 2021-22 Redistributed Allocation funding – for a total of \$397,687 – to Yuba County; and

WHEREAS, the HHSD Director seeks to submit a Director's Certification and other required documents to accept Yuba County's HDAP funding.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to submit a Director's Certification and other required documents for Yuba County's HDAP FY 2024-25 Noncompetitive Allocation funding plus FY 2021-22 Redistributed Allocation funding and any subsequent funds allocated.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to: execute, subject to review and approval of County Counsel, all documents as required by the Certifications and the resultant allocations for the term of July 1, 2024 through June 30, 2025 including subsequently extended term; execute amendments developed under HDAP, including but not limited to amendments for additional or lesser funding; and accept, transfer and administer all HDAP funds and any subsequent funds allocated/awarded for the stated period.

A copy of the executed agreement or any amendment thereto shall be filed in the office of the Clerk of the Board.


