**RESOLUTION APPROVING THE )  
EXTENDED GATING OF HAMMONTON )  
ROAD IN THE YUBA GOLDFIELDS DUE ) RESOLUTION NO. 2025-012  
TO CRIMINAL ACTIVITY AND ILLEGAL )  
DUMPING PURSUANT TO VEHICLE )  
CODE SECTION 21101 )**

**WHEREAS**, Hammonton Road between Hammonton Smartsville Road and Timbuctoo Road is a public right of way confirmed by Yuba County Superior Court Decision No. CV 99-0000265; and

**WHEREAS**, Hammonton Road provides access to the Yuba Goldfields including lands owned by the State of California on the south side of the Yuba River; and

**WHEREAS**, the County and State are experiencing excessive amounts of continual criminal activity and illegal dumping on the lands accessed via Hammonton Road; and

**WHEREAS**, the Board of Supervisors approved an 18-month closure of the aforementioned area on July 25, 2023 due to the illicit activity and high crime rates; and,

**WHEREAS**, California Vehicle Code Section 21101.4 allows for an additional 18-month continuation of the temporary closure if the closure will assist in preventing the occurrence or reoccurrence of the concerns, more specifically, public safety due to nefarious and illegal activities; and

**WHEREAS**, the Board of Supervisors held a public hearing on the 28<sup>th</sup> day of January 2025, allowing public comment about the gating of Hammonton Road pursuant to Vehicle Code Section 21101.4.

**NOW, THEREFORE, BE IT RESOLVED** that the Yuba County Board of Supervisors hereby finds, declares, orders and resolves:

1. That the foregoing recitals are true and correct.
2. That the provisions of California Vehicle Code Section 21101.4 are satisfied.

3. That the public was afforded an opportunity to be heard, and was so heard, at a public hearing of the Board of Supervisors on January 28, 2025.
4. That from and after the date this resolution is adopted, the gating of Hammonton Road is hereby authorized for an additional 18-month duration.




