WHEREAS, on April 8, 2025, the Board of Supervisors adopted a resolution declaring its intention to levy and collect assessments within Gledhill Landscaping and Lighting District and held a public hearing on said intention on April 22, 2025 in the Board of Supervisors Chambers, 915 Eight Street, Marysville, California; and

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby finds and declares and orders:

- 1) Pursuant to and in accordance with orders contained in the aforesaid Resolution, notice was duly published in the Appeal Democrat, a newspaper of general circulation published in Yuba County, one time pursuant to Government Code Section 6066.
- 2) A public hearing was held and ordered and said Board of Supervisors met to hear any protests or objections to the intention to levy and collect assessments at the aforesaid time and place.
- 3) At said public hearing all person's present were given an opportunity to hear and be heard with respect to any matter relative to intention to levy and collect assessments and no majority protest was filed.
- 4) The diagram for the district in confirmed (Appendix A).

5) Order levy and collection of assessments for the maintenance, operation and improvements to all district parks for fiscal year 2025/2026.





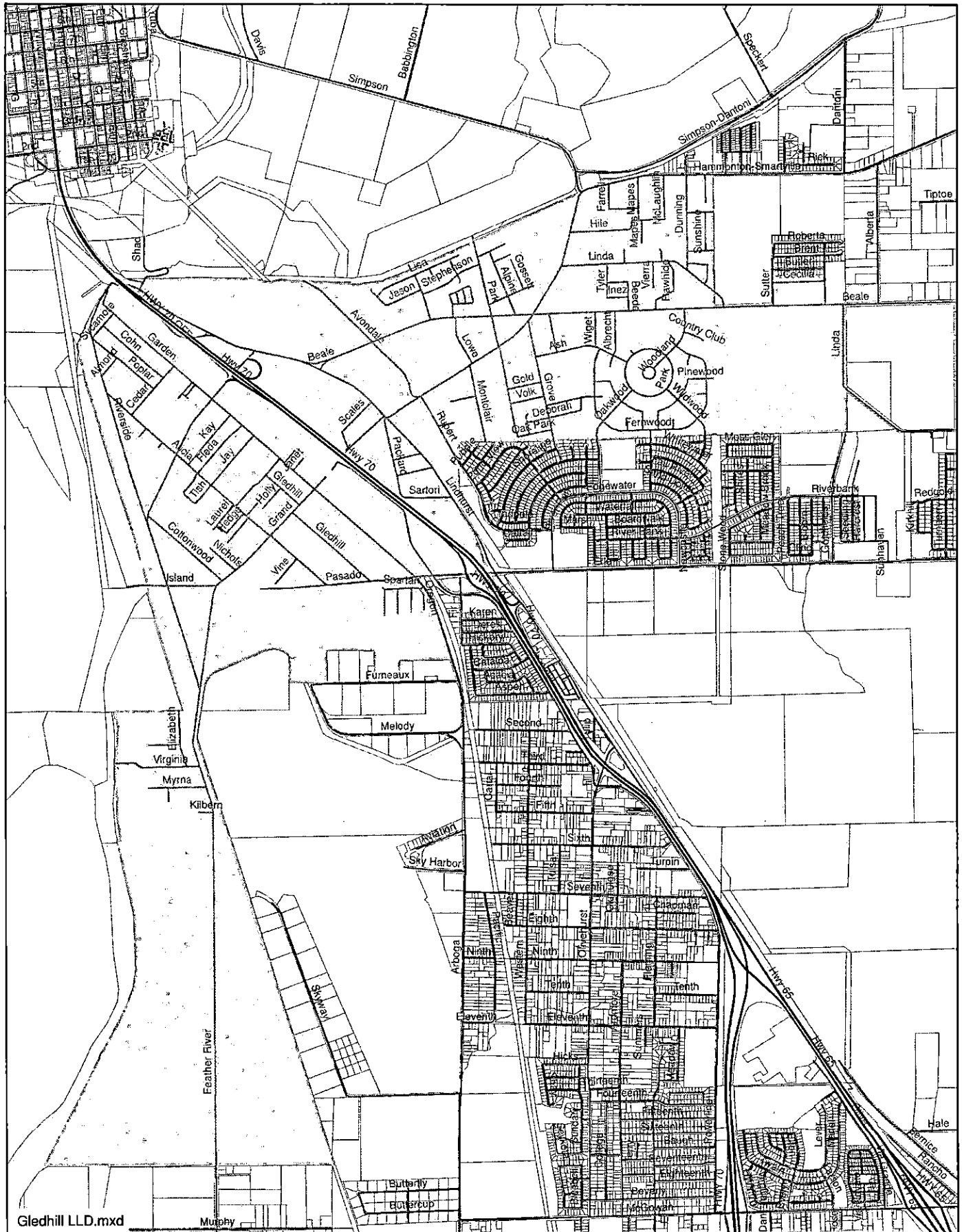
