WHEREAS, according to the US Census Bureau, by 2030, older adults will outnumber those under 18 years old in California for the first time in history; and

WHEREAS, recognizing that demographic shift, the Yuba County Commission on Aging aims to take meaningful strides to support seniors across the county and therefore created a Senior Action Plan to promote engagement with the community needs; and

WHEREAS, seniors in Yuba County have expressed a strong desire for a dedicated senior center, exclusively focused on their needs and interests, promoting socialization and healthy activities; and

WHEREAS, the Tri-Counties Community Center (TCCC) is a multi-use facility center hosting a wide variety of community events and services with strong ties to local community-based organizations and has the capacity to bring a senior program to their facility; and

WHEREAS, the Health and Human Services Department (HHSD) would like to support a program focused on senior enrichment activities located at the Tri-Counties Community Center; and

WHEREAS, the HHSD Director seeks to enter into contract with TCCC to provide these senior engagement programs upon review and approval of County Counsel.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to enter into an Agreement with the Tri-Counties Community Center for the purpose of providing these senior engagement programs.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that they approve utilizing \$12,000.00 Health and Human Services funding to support this program.

A copy of the executed Agreement, MOU or any Amendment thereto shall be filed in the office of the Clerk of the Board.
