WHEREAS, it is in the best interest of children who are in out-of-home care, who need permanency, to expedite their permanent placement; and

WHEREAS, Welfare and Institutions Code (W&IC) Section 16130 states that any county that does not have an adoption agency may establish services incident to the relinquishment of children for adoption; and

WHEREAS, The California Department of Social Services, (CDSS) agreed to provide Yuba County Agency Adoption Services under the authority of W&IC Section 16130 and in accordance with Title 22 California Code of Regulations (CCR) Sections 35127.1 through 35231; and

WHEREAS, CDSS agrees to make preliminary assessments and written reports on prospective adoptive parents, provide assessment of a child for adoptability and assume exclusive care and control of the child, for the purpose of supervising the adoptive placement until finalization of the adoption; and

WHEREAS, On December 14, 2021, the Board of Supervisors approved the CDSS Agreement for Agency Adoption Services for the initial five (5) year term of September 1, 2020, through August 31, 2025, which shall automatically renew for successive three (3) year periods unless either party wishes to terminate the Agreement.

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby authorizes the Health and Human Services Department to renew the Agreement with the CDSS for Agency Adoption Services program for the period of September 1, 2025, through August 31, 2028.

BE IT FURTHER RESOLVED that the Yuba County Board of Supervisors hereby authorizes the Chair to execute, on behalf of the County of Yuba and upon review and approval of County Counsel and Risk Management, Agreements, Amendments, and subsequent documents as related to the Agency Adoptions program. A copy of the said Agreements and documents thereto shall be filed in the office of the Clerk of the Board, County of Yuba.


