WHEREAS, California Health and Safety Code (H&SC) Sections 121450, 121451 and 121452, authorize the California Department of Public Health (CDPH) Tuberculosis Control Branch (TBCB) to distribute, for the purpose of tuberculosis (TB) control, an annual subvention, paid quarterly. This subvention is paid to any local health department that maintains a TB control program consistent with the standards and procedures established by the CDPH TBCB; and

WHEREAS, the purpose of the TB Local Assistance funds is to assist the current efforts of local TB programs to prevent, control, and eventually eliminate TB in California; and

WHEREAS, it is in the best interest of the residents of the County of Yuba to accept the funding to address the TB needs in the community while adhering to all requirements as described in the CDPH TBCB Local Assistance Funds Standards and Procedures Manual for Fiscal Year 2025-2026.

NOW, THEREFORE, BE IT RESOLVED, by the Yuba County Board of Supervisors that the Director of the Health and Human Services Department is hereby authorized to: execute, subject to review and approval of County Counsel, all documents to CDPH for the TB Local Assistance funds as required by CDPH TBCB and for the resultant allocation for the period July 1, 2025 through June 30, 2026 including

subsequently extended term; execute amendments, including but not limited to, amendments for additional or lesser funding; and accept, transfer and administer all program funds including any subsequent funds allocated for the stated period.

A copy of the said documents, or any amendments thereto, shall be filed in the office of the Clerk of the Board, County of Yuba.




