COUNTY YOUTH REHABILITATION) RESOLUTION NO. 2025-079
CAMPUS MEDICAL AND BEHAVIORAL)

WHEREAS, Yuba County Probation operates the Tri-County Youth Rehabilitation Campus (“Campus”), a juvenile rehabilitation facility located in Marysville, California, in collaboration with Sutter and Colusa Counties through the Joint Powers Authority; and

WHEREAS, the Campus is required by California’s Title 15 regulations, *Minimum Standards for Juvenile Facilities*, to provide access to medical and behavioral health services for youth detained pending Juvenile Court proceedings; and

WHEREAS, since 2019, the County has contracted with vendors to provide on-site medical and behavioral health services at the Campus, and the current medical services provider has notified the County it will vacate the facility effective September 30, 2025, creating the need for a new agreement to ensure continuity of care; and

WHEREAS, Yuba County Administrative Services issued Request for Proposal 901990 in May 2025 to solicit qualified vendors licensed in California to provide on-site and on-call medical, behavioral, and other health services, consistent with standards established by the National Commission on Correctional Health Care (NCCHC), Title 15, Title 24, and all applicable state and federal laws; and

WHEREAS, the agreement will ensure that detained youth have access to appropriate medical, behavioral health, and pharmacy services, including services required under California Advancing and Innovating Medi-Cal Justice-Involved Initiative (CalAIM JI); and

WHEREAS, on September 15, 2025, the Purchasing Agent executed the agreement due to emergency in accordance with Section 10.3 of the County Purchasing and Contract Policy Manual; and

WHEREAS, the agreement shall be effective October 1, 2025, through September 30, 2032, with the County agreeing to pay Luminous Care, Inc an amount not to exceed Five Hundred Ninety-Nine Thousand Nine Hundred Forty Dollars (\$599,940) for each twelve (12) month period, payable in equal monthly installments not to exceed Forty-Nine Thousand Nine Hundred Ninety-Five Dollars (\$49,995.00).

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby:

1. The agreement between Yuba County and Luminous Care, Inc., for the provision of on-site and on-call medical, behavioral, and other healthcare services at the Tri-County Youth Rehabilitation Campus, previously executed by the County Purchasing Agent, is hereby ratified and approved by the Board of Supervisors.
2. The Board acknowledges the contract term of October 1, 2025, through September 30, 2032, with annual compensation not to exceed Five Hundred Ninety-Nine Thousand Nine Hundred Forty Dollars (\$599,940), payable in monthly installments not to exceed Forty-Nine Thousand Nine Hundred Ninety-Five Dollars (\$49,995.00).
3. The Probation Department, in coordination with the Administrative Services Department, shall oversee and monitor the contractor's performance to ensure compliance with NCCHC standards, Title 15 regulations, and applicable provisions of CalAIM JI.
4. The Auditor-Controller is authorized to allocate and disburse the necessary funds for the agreement as approved in the County budget.


