WHEREAS, Kaiser Foundation Health Plan, Inc., on behalf of its Northern California region (“KFHP”), has made Population Needs Assessment (“PNA”) funds available to local health jurisdictions; and

WHEREAS, PNA funds are intended to support completion of a local health jurisdiction’s Community Health Assessment (“CHA”) and Community Health Improvement Plan (“CHIP”); and

WHEREAS, Yuba County Health and Human Services Department (“HHSD”), through its Public Health Division, has been allocated PNA funds in the amount of \$24,093 for the period of June 1, 2025 through May 31, 2026, to implement strategies specific to Yuba County’s CHIP; and

WHEREAS, HHSD intends to use these funds towards the development of an interactive Geographic Information System (“GIS”) map showcasing Yuba County’s parks, trails and recreation areas to make them easier for residents and visitors to find and enjoy; and

WHEREAS, it is in the best interest of its residents for the County of Yuba to utilize these funds to develop and implement this tool so that the residents have a centralized map of parks, trails and recreational sites in one location.

NOW, THEREFORE, BE IT RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is authorized to enter into an Agreement with KFHP for the PNA funds for the term of June 1, 2025 through May 31, 2026, including the subsequently extended term.

BE IT FURTHER RESOLVED by the Yuba County Board of Supervisors that the HHSD Director is hereby authorized to: execute, subject to review and approval of County Counsel, all documents as required by the PNA funds; execute amendments, including but not limited to amendments for additional or lesser funding; and accept, transfer and administer all funds and any subsequent funds allocated for the stated period. A copy of the said agreement or any amendments thereto shall be filed in the office of the Clerk of the Board, County of Yuba.
