**WHEREAS**, the State of California has authorized Help American Vote Act (HAVA) grant funds, administered by the US Election Assistance Commission (EAC), for California counties. The funds are for activities to improve the administration of elections for Federal offices, including the enhancement of election technology and election security improvements, as authorized under sections 101, 103, 104 of the Help America Vote Act; and

**WHEREAS**, Yuba County elects to participate in the Help America Vote Act (HAVA) Grant Program and apply for a grant in the amount of \$8,324.38; and

**WHEREAS**, to participate in the HAVA Grant Program, the County must enter into an agreement with the California Secretary of State.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the County of Yuba as follows: The Board of Supervisors finds that a vital public interest is served by enhancing election technology and making election security improvements and that the Clerk/Recorder-Registrar of Voters is hereby authorized to enter into an Agreement with the California Secretary of State for HAVA funds; and

**BE IT FURHTER RESOLVED** by the Board of Supervisors of the County of Yuba as follows: That the Clerk/Recorder-Registrar of Voters is hereby authorized to:

1. Accept an amount not to exceed \$8,324.38 for reimbursement for the period beginning July 1, 2025 and ending on December 31, 2026
2. Execute documents as required by the Agreement during the stated period
3. Accept and allocate funds as designated for the stated period
4. Amend the Agreement for additional or lesser funding and
5. Execute Amendments or memorandums of understanding developed under this grant.

A copy of the said Agreement, or any amendments thereto, shall be filed in the office of the Clerk of the Board, County of Yuba.




