WHEREAS, The County of Yuba is required to provide fair, impartial, and legally compliant personnel hearings in accordance with applicable provisions of state law, County ordinances, County personnel rules and due process requirements; and

WHEREAS, the California Department of General Services, Office of Administrative Hearings, provides qualified, independent Administrative Law Judges to conduct administrative hearings for public agencies, including personnel and disciplinary matters; and

WHEREAS, the use of Administrative Law Judges from Office of Administrative Hearings ensures neutrality, procedural consistency, and legal sufficiency in the conduct of personnel hearings; and

WHEREAS, the County has a continuing need for Administrative Law Judge services to conduct personnel hearings on an as-needed basis; and

WHEREAS, an agreement between the County of Yuba and the California Department of General Services, Office of Administrative Hearings, for the provision of Administrative Law Judges services was executed by the County Purchasing Agent in accordance with delegated purchasing authority; and


WHEREAS, the Agreement establishes the terms and conditions under which Office of Administrative Hearings will provide Administrative Law Judges services to the County, including compensation in accordance with Office of Administrative Hearings established fee schedule and reimbursement of allowable costs; and

WHEREAS, the Board of Supervisors desires to ratify the Agreement and all actions taken to date thereunder, finding that the Agreement is in the best interest of the County and supports the fair and lawful administration of County personnel matters.


NOW, THEREFORE, BE IT RESOLVED that the Yuba County Board of Supervisors hereby ratifies the Purchasing Agent execution of the professional services agreement entered with the California Department of General Services, Office of Administrative Hearings for Administrative Law Judges services dated February 6, 2026.
