WHEREAS, the California Department of Housing and Community Development (the “Department” or “HCD”) previously awarded the County for the Community Development Block Grant Program (“CDBG”), made available from the U.S. Department of Housing and Urban Development (“HUD”), which allowed the County to collect CDBG Program Income; and

WHEREAS, the Community Development and Services Agency, on behalf of the County of Yuba, wishes to submit an application to HCD to expend Program Income towards the following CDBG activity; and

WHEREAS, it is the recommendation of the Community Development and Services Agency that the Yuba County Board of Supervisors adopt a resolution authorizing the submittal of an application for the CDBG Program, and the execution and submittal of all grant application materials; and

WHEREAS, the Community Development and Services Agency recommends and requests the Board of Supervisors to authorize and direct the Director of Community Development and Services Agency, or its designee, to execute and deliver all documents pertaining to a grant application, and act on the County’s behalf in all matters pertaining to such applications; and

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby declares:

Section 1. That the above recitals are all true and correct.

Section 2. That the Yuba County Board of Supervisors has reviewed and hereby adopts a resolution authorizing the Community Development and Services Agency staff to submit an application in the aggregate amount, not to exceed, of \$952,594 to the California State Department of Housing and Community Development for the following CDBG activity; and

Activity (e.g. Public Services, Infrastructure, etc.)	Dollar Amount Being Requested for the Activity
Single-Unit Residential Rehab	\$ 952,594

Section 3. That the Yuba County Board of Supervisors approves the use of Program Income in an amount not to exceed \$952,594 for the CDBG activities described in Section 2; and

Section 4. That the Yuba County Board of Supervisors acknowledges compliance with all state and federal public participation requirements in the development of its applications; and

Section 5. The County Board of Supervisors hereby authorizes and directs the Director of Community Development and Services Agency, or its designee, to execute and deliver all applications and act on the County’s behalf in all matters pertaining to all such applications; and

Section 6. If an application is approved, the Director of Community Development and Services Agency, or its designee, is authorized to enter into, execute and deliver the grant agreement (*i.e.*, Standard Agreement), any recordable or nonrecordable contract documents, and any and all subsequent amendments thereto with the State of California for the purposes of the grant; and

Section 7. If an application is approved, the Director of Community Development and Services Agency, or its designee, is authorized to sign and submit Funds Requests and all required reporting forms and other documentation as may be required by the State of California from time to time in connection with the grant; and

Section 8. This Resolution shall take effect upon its adoption.


