WHEREAS, on a periodic basis certain governmental, private, public safety and health care agencies request that the Director of the Office of Emergency Services (OES), and/or designees sign Contracts Agreements, Cooperative Agreements, Memorandums of Understanding and/or Memorandums of Agreements (all such documents are hereinafter referred to as “Contracts”) for the grant related services to that healthcare agency; and

WHEREAS, on a periodic basis the OES Director and/or designees is requested to sign Contracts for the grant administrative services for governmental, private, public safety and healthcare agencies; and

WHEREAS, on occasion, the OES Director and/or designees is requested to sign Contracts and/or related documents for the grant requirements eligibility for governmental, private, public safety and healthcare agencies; and

WHEREAS, annual basis, the OES Director and/or designees is requested to sign Contracts and/or related documents for grant reimbursement disbursement for governmental, private, public safety and healthcare agencies; and

WHEREAS, it is in the interest of efficient and effective county government to have one Resolution of the Board of Supervisors authorizing the OES Director and/or designees to execute, on behalf of the County of Yuba, certain Contracts; and

NOW, THEREFORE, BE IT RESOLVED, the Yuba County Board of Supervisors hereby authorize the OES Director and/or designees to enter into and execute, on behalf of the County of Yuba and upon review of the County Counsel, certain Contracts with government agencies, private agencies, contractors and/or healthcare agencies; and further, the Director and/or designees is granted permission to amend such Contracts and execute such Amendments or related documents, upon review of County Counsel, as required for stated period; and

BE IT FURTHER RESOLVED, the Yuba County Board of Supervisors hereby authorizes the OES Director and/or designees to disburse grant funds to healthcare agencies in Contracts.

A copy of each executed Contract shall be filed with the Clerk of the Board of the Yuba County Board of Supervisors.




